1. This Agreement constitutes an order for event photographs. It is understood that the contracting party vis. _____ is making a specific hire of photographer Michael E. Bérubé's time and talent and shall pay him a Shooting Fee for the express purpose of photographing documentary and posed images of the event accordingly:

This Shooting Fee will be billed from _____ am/pm on the date of _____ (at least 30 minutes prior to ceremony) and **all payments are due and expected at the completion of the event, before the photographer leaves the site.** A Retainer of \$500.00 will reserve the above date and times for the photographer's services. If the event dates or times are changed or canceled for any reason on or prior to the event, *this Retainer is non-refundable.* If the event is held in accordance with the terms of this agreement, the Retainer is applied to the balance of the Shooting Fee. *If any of the shooting locations (above) are more than 2 but less than 4 hours travel (one way) from Denmark, ME an additional \$200 will be charged for travel expenses. One Way Travel Time _____ (Arrangements for events beyond 4 hrs one way are attached to this Agreement.)

2. All images that the photographer deems standard will be digitally uploaded to a password-protected website on the World Wide Web for a duration of no less than 90 days. Archival Disc(s) with all of the the final standard high-resolution images from the event (aka digital negatives) will accompany these first prints at no additional charge. The photographer will provide the contracting party a complete set of first prints in Colour and B&W of the best 200 images from the standard images made by the photographer of the event OR will provide a first prints book with all of the standard images that are uploaded and on the Archival Disks printed on bound pages at the client's choice..

3. Duplicate complete sets of first prints in Colour or B&W version or an additional First Prints Book are available at an additional cost of \$299 each. Additional Sets of First Prints ___ Colour ___ B&W ___ First Prints Book

4. All images that the photographer deems standard (aka final high-resolution images) and any subsequent images made from them shall remain the exclusive copyright of the photographer, however, upon final payment, the contracting party is granted unlimited personal usage and reprint license to the images. The photographer reserves the exclusive copyright to use any and all images or parts thereof created by him at the event for advertising, promotion, display or any other purpose thought proper by him without any recompense whatsoever to any party.

5. Although all due care will be taken with the images created at the event, the photographer limits any liability for the loss, damage, or failure to deliver any or all pictures for any reason, to the return of a percentage of the Shooting Fee (Article 1, above) equal to the percentage of services not delivered. Any and all other costs related to this Agreement remain the responsibility of the contracting party.
